SUPPLEMENTARY REGULATIONS
CHAPTER 1 - STANDARD REQUIREMENTS

1 EVENT TITLE, DATE & VENUE

The event shall be known as the Twilight Short Circuit Super Sprint, Round 1 AMR 2008 CAMS WA Speed Event Series to be held on 16 February 2008 at Barbagallo Raceway Wanneroo.

2 ORGANISATION AND STATUS

- (a) The event shall be held under the International Sporting Code of the Federation Internationale de l'Automobile (FIA), the National Competition Rules (NCR) of Confederation of Australian Motor Sport Ltd (CAMS), the Speed Event Standing Regulations, the Non-Competitive Speed Event Standing Regulations, the CAMS Passenger in Vehicle Guidelines, WA Speed Event Series Regulations, these Supplementary Regulations and any further Regulations and instructions to Competitors that may be issued.
- (b) This event will be conducted under and in accordance with the CAMS Risk Management and OH&S policies, which can be found at www.cams.com.au
- (c) The event shall be a Multi Club Multi Car Speed Event.

4 CIRCUIT DETAILS

- (a) **Length:** Short circuit 1.7601km.
- (b) **Direction:** Clockwise.

5 ENTRIES

- (a) **Opening date:** Entries open on publication of these Regulations.
- (b) **Closing date:** Friday 15 February 2008.
- (c) **Entry fee:** \$100.00 per driver (inclusive of GST) payable to the WA Sporting Car Club.
- (d) **Entry lodgement address:** PO Box 267, WANNEROO WA 6946.
- (e) **Restricted entries:** The organisers will restrict entries to 110 participants and reserve the right to refuse any entry without assigning any reason therefore in accordance with NCR 83.

6 ENTRY AND EXIT TO CIRCUIT

- (a) Competitors will assemble at the **north ramp**.
- (b) Entry to the paddock from the track will at all times be by the **south ramp**.
- (c) **NOTE:** This is the opposite use of entry to normal WASCC race meetings.

7 VEHICLES

8 START/NUMBER OF RUNS

- All competitors are required to register at the Race Office from 1400 hrs. Scrutiny “tear offs”, membership cards, competition licences and CAMS log books (if applicable) must be presented.
- Practice on the short circuit will commence at 1600 hrs. Driving instruction by a WASCC driving instructor is allowed in the practice sessions. Practice laps will be strictly limited in numbers and must not be driven at full competitive speeds.
- The event is scheduled to start at 1630 hrs. A minimum of **four** runs comprising of **three** laps shall be given to each competitor.
- It shall be a multiple start event. Each competitor will be directed onto the course from pit exit at one-second intervals. Competitors are requested to group themselves in the order of fastest to slowest in each group to minimise passing on the circuit.
- Between 1630 and 1900 hrs preference for runs will be given to Competitors whose vehicles do not have adequate lighting for running in the dark. It will be up to the Competitors of such vehicles to present themselves in good time at the marshalling area.
- There shall be a dinner break between 1930 and 2030 hrs.
- The event is scheduled to finish at approximately 2230 hrs.

9 LICENCE REQUIREMENTS

Competitors must hold a minimum of a CAMS Level 2S or 2SJ Licence and be a member of a CAMS Western Australian affiliated Car Club. Competitors may obtain a CAMS Level 2SE Licence, however, this Licence is only valid for one event per calendar year.

10 PARENTAL CONSENT

If any Competitor or driver is under 18 year of age the consent of his/her parent or guardian must appear on the Entry Form.

11.2 Procedure

Inspection is to be conducted in the week prior to the event concerned. Competitors must ring the person they want their car inspected by, and arrange an inspection time. Scrutiny can only be carried out for metropolitan competitors in the week prior to the event and only at the above locations **by appointment. No scrutiny of metropolitan vehicles will be available at the venue prior to the event, unless the vehicle is unregistered (trailed) to the venue.**

Should a metropolitan competitors vehicle be presented at the circuit on the day without having passed scrutiny a \$50 fee will apply (payable on the spot) and the Event Organisers reserve the right to refuse to check the vehicle in question, or place it at the rear of the scrutiny line.

The inspection point will have scrutiny forms. The forms have a tear off section at the bottom which will be endorsed by the inspector, and the Competitor is to present it at registration on the day of the event. The main body of the form will be completed by the scrutineer, and will be delivered to the organiser.

11.3 Country scrutiny arrangements

On the day scrutiny will commence at 1400hrs and conclude at 1500 hrs at the venue.

11.4 CAMS Log Booked Competition Vehicles that have been subject to WA Pre Season Vehicle Inspection Audit

Vehicles that have had a 2008 Pre Season Vehicle Inspection Audit must also attend scrutiny.

11.5 All Competitors

- (a) Your helmet must be presented for inspection and approval at time of scrutineering.
- (b) Membership cards and appropriate CAMS Licence, and log book (if applicable) must be produced during scrutiny and on request during the meeting.
- (c) Race numbers will be provided on the day.
- (d) No car may participate unless it has passed scrutiny.
- (e) Any car which, after approval, is dismantled or modified in any way which might affect the safety of the vehicle or raises questions as to its eligibility, or is involved in an accident having similar results, must be re-submitted for scrutiny for approval prior to any further participation.
- (f) Any car or driver may be prohibited from practice or the competition for safety reasons.

12 AUTOMATIC TIMING

All vehicles will require a Dorian Data-1 timing transmitter to be fitted prior to the commencement of practice. Competitors who do not have a transmitter will be issued one at the Race Office. The mounting of the transmitter is the responsibility of the competitor and cable ties will be required. It is the competitor's responsibility to cover any costs related to repairs and or replacement of the transmitter if lost or damaged. It is also the responsibility of the competitor to return the transmitter to the Race Office at the conclusion of your final run.

13 COMPETITORS' BRIEFING

A Competitors' Briefing at 1530 hrs will be held at McCrackan House. All competitors **MUST** sign on. Any competitor failing to attend or arriving late at the Briefing should seek out the Clerk of Course who will consult with the Stewards to determine whether they are permitted to run and under what conditions, e.g. reduced number of runs.

14 INSURANCE

Combined Liability Insurance has been effected by the Promoters. All Competitors and officials are covered by the Motor Sport Personal Accident Insurance Policy. For further details, see Appendix I of the CAMS Manual of Motor Sport.

Every Competitor and driver before taking part in any competition shall sign the Disclaimers and Competitors Statement on the Entry Form.

15 PROTESTS

Any protest must be lodged in accordance with the Provision of Part XII of the NCRs.

16 POSTPONEMENTS, ABANDONMENT OR CANCELLATION OF COMPETITION

The Organisers reserve the right to abandon the event in accordance with the Provisions of NCR 59.

17 USE OF PROHIBITED SUBSTANCES

- (a) During any competition, consumption of alcoholic beverages in the paddock, pits or any other portion of the competition venue under control of the officials is expressly forbidden until all practice or competition activity is concluded for each day. Any driver or crew member who is found to be affected by alcohol on the day of the event or practice therefore shall not be permitted to participate. Refer NCR 145A of the current CAMS Manual. In addition, the persons concerned will be subject to the Articles of the Procedure for Alcohol Testing and CAMS Drugs in Sport Policy.
- (b) Other Prohibited Substances
The CAMS Drugs in Sport Policy, as appears in the current CAMS Manual of Motor Sport and as amended from time to time, is recognised as an integral component of the NCR and is duly authorised as such.
In any areas where the National Competition Rules and the Drugs in Sport Policy conflict, the Drugs in Sport Policy will take precedence.
Competitors, crew or officials may be tested for alcohol or other drugs at any time during the event(s). This regulation serves as the required 24-hour notice to Competitors, Crew and Officials.

18 AWARDS

Trophies will be presented for the winners of each class and for first, second and third overall.

19 DETERMINATION OF WINNERS

The results will be determined by the fastest overall time of the day not including the practice run and ranked in ascending order of time. Should two or more competitors record the same time the competitor next best fastest time shall determine the winner.

20 APPAREL

All Competitors must wear helmets and in open vehicles, goggles/visors complying with a standard as listed in Schedule D of the current CAMS Manual of Motor Sport. CAMS recommend that competitors wear an approved full-face helmet when driving in open vehicles (refer Schedule D of the current CAMS Manual of Motor Sport). Fire resistant clothing is recommended, otherwise, Competitors must wear woollen or cotton clothing covering the body from ankles to wrists and neck, and suitable and appropriate footwear.

21 SAFETY - CARS

The attention of competitors is drawn to Schedules A & B of the General Requirements of Automobiles found in Section Six and the Standing Regulations for Speed Events in the current CAMS Manual of Motor Sport.

All cars must:

- (a) Be fitted with Seat Belts to AS E35 or of a type specifically approved for use by CAMS.

- (b) Have a securely fitted fire extinguisher, which complies with AS 1841 (save that extinguishers which meet AS1841.2 are not permitted). The Chief Scrutineer will be paying special attention to mounting brackets for fire extinguishers. We recommend that competitors discard plastic brackets in favour of metal ones, which should be mounted in a suitable position and of a type and capacity as specified in Schedule H, of the CAMS Manual of Motor Sport. The fitment of an 'on board' system approved for use by CAMS is an acceptable alternative.
- (c) Having, on the external coachwork, a blue triangle of sides 150mm, this indicates the position of the battery.
- (d) For vehicles competing after sunset the complete lighting system must consist of at least two dipping headlamps each of at least 125mm diameter or 160cm² area, each of 35 Watts minimum power; and two tail lamps each of three Watts minimum power (both the above sets of lamps must be not less than 600mm apart) and at least one stop lamp of 20 Watts minimum power. If only one such stop lamp is fitted, it shall be in the central vertical plane of the vehicle. At the start of the competition, headlamps must be in effective working order and correctly aligned. **The lens must be protected by a translucent shield.**

Cars not road registered must:

- (a) Be fitted with a scatter shield if required under the provisions of Schedule M of the current CAMS Manual of Motor Sport.
- (b) Not be fitted with any steering column locking device.
- (c) If not equipped with a suitable cross member then to be fitted with a strap that will prevent the tail shaft falling to the ground in event of a component failure.
- (d) Be fitted with crankcase breather/s discharging to atmosphere have fitted to such breather/s an oil trap container which must be empty at the start of competition, of a capacity of at least two litres for vehicles under 2000cc or three litres for vehicles over 2000cc.

The use of recapped or reconditioned tyres is forbidden. Tubeless tyres must be fitted to optimum rim size only. Fuel must be 'Commercial Fuel' as defined by CAMS, Schedule G of Section 6 of the current CAMS Manual of Motor Sport. Roll bars are not compulsory in closed speed events, but are recommended. All cars must be adequately muffled.

22 COMPLIANCE WITH INSTRUCTIONS

Failure to follow the direction of any official will render a competitor liable to exclusion.

23 PRESENTATION

Awards will be presented at the conclusion of the event at McCrackan House at approx. 2230 hrs.

24 CATERING

A BBQ dinner will be held during the dinner break. Refreshments will be available.

25 DRIVER CONDUCT

Any driver who

- (a) Cuts corners, OR
- (b) Dislodges corner markers(s), OR
- (c) Sprays quantities of dirt or gravel on the racing surface

May have five seconds added to the time for the lap/run that the incident takes place on. Furthermore, Competitors who persist in such behaviour may be excluded from further competition.

The Clerk of Course and their assistants and other officials appointed at the event by the Clerk of Course shall be a judge of fact for such incidents.
